Call to Order: Meeting was called to order by Chair Commissioner Uyeda at 9:00 a.m. in the Gallery Room of the Beach Club, 121 Marina View Drive, Port Ludlow, Washington 98365

Chair Commissioner Uyeda asked that Commissioner roles and duties be put onto the next agenda for discussion. Commissioner Smith noted that a Commissioner billing pattern should be established by resolution, according to the County Auditor.
